# 2025-26/16 DEMISE OF TRUSTEE

The Board noted with sadness, the passing away of Col. Anil Sachdev, one of the founder-trustees, on 26th September'25 owing to prolonged illness. The Trustees placed on record their deep appreciation of the contribution made by Col. Anil Sachdev to the cause of Koshika and his untiring efforts to help the needy, since the inception of the Foundation. The Foundation and its beneficiaries owe deep gratitude to the memory of Col. Sachdev.

## 2025-26/17 CHANGE IN SIGNING MANDATE FOR ALL KOSHIKA BANK ACCOUNTS

## 2025-26/18 APPOINTMENT OF NEW TRUSTEE

In view of the growing activities & expanding geographical footprint of the Trust, and consequent upon the demise of Anil Sachdev, Trustee, it was decided to induct a new Trustee, who could contribute meaningfully to the cause being pursued by the Trust. The Chairman placed before the Board of Trustees, resume of a potential Trustee. Copy of this resume is attached herewith. This lady, Ms Vatsala Joseph has been advising the existing Board of Trustees of Koshika from its very inception, on pro bono basis. She has long standing in-depth experience in the social sector, having worked for about 33 years with various Indian and International non-profit organizations of repute. The Board noted the same and placed on record that they were in favour of the inclusion of Ms Vatsala Joseph who they felt would greatly contribute and help the Trust grow.

After discussions, it was decided to pass the following resolution:

"RESOLVED UNANIMOUSLY THAT pursuant to clause 5 & 6 of the Trust Deed that Ms Vatsala Joseph be included as a Trustee w.e.f. 18th October, 2025 for the period ending on 30th April, 2027.

**RESOLVED FURTHER THAT** a copy of the registered Trust Deed be shared with Ms Vatsala Joseph so that she is aware of the accountability and responsibility in relation to the Trust operations."

## 2025-26/19 INCOME TAX SCRUTINY CASE

A notice was received online from the Income Tax department intimating that scrutiny assessment under section 143(3) had been initiated for FY 2023-24. Koshika responded well before the last date of 8th July'25 informing the Department that we will be glad to furnish required details and co-operate with the Department for completing the proceedings. A detailed reply, with requisite documents, in response to the questionnaire from the Income Tax department, was filed in time on 5th August'25. Further advice from the Income Tax department is awaited.

## 2025-26/20 AUGMENTING DONATIONS

In view of the substantially increased outlay planned for the current FY, it was emphasized that efforts needed to be made more vigorously to augment donations. Strategies were chalked out to associate with new CSR donors. Also, a plan had been initiated to reconnect with all existing donors to honour them with a framed "Thank You" on behalf of Koshika Foundation, apprise them of the work being done and plans for the current year, and request for increased share out of their CSR funds. Discussions are underway with DTU to solicit CSR funds from some corporates and applications are being framed for that purpose; these will be lodged with potential corporate donors soon. Also, some more new donors will be approached by some of the trustees.

# 2025-26/21 VOLUNTARY CONTRIBUTIONS BY TRUSTEES FOR ADMIN EXPENSES

It was brought to the notice of all concerned that contributions by a trustee, for meeting admin expenses, which were fixed at voluntary contribution of Rs 72000 per trustee per annum, had not been received. The concerned Trustee is requested to do the needful.

## 2025-26/22 OTHER MATTERS

The trustees were informed about the following:

- Accounts for FY 2024-25 have been audited. A clean audit report without any
  qualifications or adverse remarks was issued by the auditors, and the same was filed
  online by them. The ITR for FY 2024-25 has also been filed. Both these filings were
  completed in time i.e., before 31st October, 2025.
- Applications for renewal of 12A and 80G have already been filed online, well within the stipulated time frame.
- 3) Matters are proceeding with DTU with regard to the the book about the story of Koshika, podcast and the TED talk. All trustees have been informed progressively and will be kept informed going forward as well.
- 4) A proposal has been received from SRCC Children's Hospital, Mumbai for our support for children's heart surgeries and cath procedures. The matter was discussed, and while all were in favour of going ahead witht his association, yet it was understood that such an engagement would depend on inflow of donations. So, depending on inflow of donations in next couple of months and also the new cases of children's heart surgeries/procedures from existing partner Hospitals, a final decision in this regard will be taken.

All requisite compliances have been completed in time.
